Track rental includes use of 1.82-mile asphalt road course, 1/3-mile hot pit, paved paddock and parking lot areas, clubhouse great room, classrooms, commercial kitchen and outdoor deck. Grassy areas adjacent to asphalt parking may be used for auxiliary/overflow parking with prior arrangements with track representatives.

Two (2) H<sub>2</sub>R safety workers will be included in the rental price, additional workers are available at \$150 per day. Use and placement of workers to be agreed upon by both parties prior to the day of the event.

Gates may open no earlier than 7am. Gates may close no later than 7pm. Track can go 'hot' as early as 9am. Track must go 'cold' by 6pm.

No drugs or alcohol permitted on premises. No spectators allowed on premises.

All pets must remain on leash and are not allowed in the paddock area. Children are welcome but must remain in clubhouse and adjacent grounds. Absolutely no children in the paddock area.

All cars must pass sound level test of 99dBA trackside or 99dBA at 30 feet as sound tested in upper lot, whichever is louder.

Lessee must strictly control gate ingress/egress and must obtain and maintain required waiver signatures throughout the day.

Lessee is restricted to 60 participants (including instructors) per day. Arrangements for larger events must be made in advance with H<sub>2</sub>R.

H<sub>2</sub>R members are allowed unfettered access to the clubhouse and parking areas during the event without charge.

### Required Additional Fees:

Two EMTs with Emergency Vehicle or Brush Truck. Emergency vehicles manned by EMTs will be available from H<sub>2</sub>R contractors. If vehicles are to be provided by an entity besides H<sub>2</sub>R contractors, arrangements must be made with H<sub>2</sub>R ahead of time.

Fire suppression/rolling tow truck can be provided by H<sub>2</sub>R. Other units must be approved by H<sub>2</sub>R.

An insurance rider is required that meets the minimum coverages required by H<sub>2</sub>R and its insurance provider, Jones Brown Motorsports. Insurance for HPDEs is also available via H<sub>2</sub>R for \$350 per event day.

A 20% non-refundable deposit is required to fully secure any reserved date.
